The grant of above Grade Pay/pay level is purely personal to the officials and shall not amount to functional/regular promotion nor would require creation of new posts for the purpose. The Grade Pay to the above officials is subject to the condition that they will continue to perform such duties as are entrusted to them together with retention with old designation.

No stepping up of pay in the Pay level will be admissible with regard to junior getting more than the senior on account of pay fixation and no past case will be reopened.

The seniority of the above officials in their respective grades will remain unchanged. The grant of above grade pay to the above officials will be further subject to the other terms and conditions mentioned as per OM, Deptt. Of Personnel & Training Dated 19-05-2009 referred to above.

With regard to fixation of pay on grant of financial up gradation under MACP Scheme Government Servant has an option under FR 22 (1)(a)(1) to get pay fixed in the pay Level either from the date of up gradation or from the date of next increment. Accordingly, all employees must get their pay fixed within one month from the date of issue of this order. The grant of recommendation for higher pay level is subject to obtaining an undertaking that in the event of overpayment, if any, the same will be recovered from their pay without any notice.
