SHOW CAUSE NOTICE

1. Whereas, Ms. Sithara Jose, Nursing Officer (**Emp.ID-126218**), joined GTB Hospital w.e.f. 05.05.2009, is unauthorizedly absent from her duty since 16.02.2016. Vide memorandum dated 23.01.2018, Show cause Notice dated 12.10.2020, 28.02.2024, she has already been given several opportunity to join her duty and for written explanation for her unauthorized absence from duties.
2. And whereas, being on unauthorized absence from her duties, an Advertisement/Notification has been published in news papers that in terms of Rule 12(2) of CCS Leave Rules 1972 she will be treated as resigned from service with retrospective effect she will not respond/resume with 15 days from the date of publish of notice.
3. And whereas, vide application dated 12.03.2024; she has submitted her resignation from the post w.e.f. 16.02.2016. As per Accounts Branch, GTBH, and overpayment of Rs. 2,79,270/- has been made to her, Accordingly, vide Memorandum dated 16.05.2024, she has been directed to deposit the above said overpayment through DD in favour of PAO-VIII, at the earliest, so that her resignation request may be processed further.
4. And whereas, she has neither deposited the overpayment Rs. 2, 79,270/- nor submit any correspondence/reply has submitted in this regard till date.
5. Now, Therefore, request of resignation in r/o Ms. Sithara Jose, Nursing Officer is not acceptable at present as the overpayment is still due on her part and she is again hereby directed to deposit Rs. 2, 79,270/- through DD in favor PAO-VIII, within 07 days from receipt of this letter, failing which Disciplinary Proceeding may be initiated against her as per CCS (Conduct) Rules, 1964.
6. This issues with prior approval of Medical Director, GTBH vide Dy. No. 2093 dated 24.06.2024.
