**ORDER**

1. Consequent upon her exercising the option for coverage under Central Civil Services (Pension) Rules, 1972 (Now 2021) in place of New pension System in pursuance of the Department of Pension and Pension Welfare (D/o P &PW) Office Memorandum No. 57/05/2021-P&PW(B) dated 3<sup>rd</sup> march, 2023 followed by Service Department GNCT of Delhi Office Memorandum No. F..16(1)(I)/Misc./2023/S.III/Vol.III/1811-1813 dated 16/10/2023 and subsequently finding her eligible for coverage under the CCS (Pension) Rules, 1972 (Now 2021) in accordance with aforesaid Office Memorandum(s), Mrs. Vandana Arora, Senior Dietician, initially appointed to the Group C post of Dietician w.e.f. 21/04/2006 on the basis of vacancy notified in the year 2003, is placed under Old Pension Scheme i.e. CCS (Pension) Rules, 1972 (Now 2021).

2. The corpus of the NPS account of Mrs. Vandana Arora, Senior Dietician, is to be accounted as per instructions contained in para 8 of D/o P&PW's O.M. No 57/05/2021-P&PW(B) dated 03.03.2023 which is reproduced below:-

- i. Adjustment of Employee contribution in Accounts: Amount may be credited to the individuals GPF account and the account may be recasted permitting up-to-date interest (Authority-FR 16 & Rule 11 of GPF Rules).
- ii. Adjustment of Government contribution under NPS in accounts: To be accounted for as (-) Dr. to the object head 70- Deduct Recoveries under major head 2071- pension and other retirement benefit -Minor Head 911- deduct recoveries of overpayment (GAR 35 and para 3.10 of List of Major and Minor Heads of Accounts).
- iii. Adjustment of increased value of subscription on account of appreciation of investments: May be accounted for by crediting the amount of Govt. Account under M.H.0071-Contribution towards pension and other Retirement benefits 800-other receipts (Note under the above head in LMMHA).
