ORDER

In pursuance of Services Department Order No. 97 issued under letter no. F.No.4/1/2024/S.II/2422-32 dated: - 30.12.2024 followed by GTB Hospital relieving order no. F.No. F. 1(814)/VigStatusMinisterial/2024/4090-96 dated: - 31.12.2024 and order No. F.4 (2014)/TP/1/E-I/Vol-II/5479-87 dated:- 10.01.2025 to take **Sh. Naresh Kumar Gautam, Sr. Assistant (Emp. Id- 43396007)**, on Strength of GTB Hospital, the official has exercised option that his pay on the date of promotion, may initially be fixed at the next higher cell in the pay level of promoted post or pay level granted under promotion, above his pay in the lower post/pay level, which may be re-fixed on the date of accrual of next increment in the pay level of the lower grade on the basis of the provisions of FR 22(1)(a)(1) read with DoP&T OM No. 13.02.2017-Estt.(Pay-I) dated:- 27 July 2017.

He has also submitted representation that his one increment was missing in his pay/salary, which was due on 01.01.2019 and the same was granted on 07.07.2019. The pay fixation of the official was checked, it has been found that the pay fixation is correct upto 01/7/2018 but DNI was not mentioned inadvertently on account of 2nd MACP w.e.f. 19.06.2018 in Level 3.

The official was granted 2nd MACP in L-3 w.e.f. 19.06.2018 and promoted to the post of Jr. Assistant (L-2) w.e.f. 29.06.2018. Upon grant of 2nd MACP the official opted for fixation of pay from date of next increment in lower grade pay. Instead of allowing first increment after six months and subsequent increments after one year on notional basis since the official had neither cleared type test nor granted exemption from passing typewriting test by Services Department at that point of time, all increments were allowed after one year vide pay fixation order dated 18/9/2019. The official has recently been granted exemption from passing type writing test w.e.f. 05/1/2021 as DOB of the official is 05/01/1976. Hence pay of **Sh. Naresh Kumar Gautam, Sr. Assistant** is hereby corrected/re-fixed as under:-
