**ORDER**

In pursuance of Directorate of Vigilance letter No. F.99/4/2025/DOV/3198 dated 28.03.2025 followed by Department of H&FW, GNCTD letter no. F.No. 11/127/H&FW/HR-MED/2024/#112773786/508 dated 26.03.2025 Dr. Anil Kumar Yadav, AMS(A), is granted earned leave w.e.f. 19.05.2025 to 06.06.2025 (Prefix 18.05.25) with permission to travel abroad to USA on personal visit on the following terms and conditions:-

1. That the duration of stay abroad should not exceed beyond 19 days 19.05.2025 to 06.06.2025 (prefix- 18.05.25) during Earned Leaves;
2. Leave so granted will not be extended by him under any circumstances from abroad;
3. He will not accept any employment or undergo any training under the foreign Government under any circumstances.
4. Leave salary etc. shall be paid to him in Indian currency and no financial implication will be involved on the part of the Government of India for the visit;
5. His overstay abroad, after expiry of the sanctioned leave, if any, will be treated as unauthorized absence from duty leading to disciplinary proceedings against him;
6. He will not resign from abroad;
7. He will not accept hospitality while abroad from foreign Govt. etc. and friends/relatives with whom he has any official dealing;
8. In case of extension for stay due to medical reasons, a medical certificate has to be produce from a hospital approved by the concerned Indian Embassy. Any other certificate from any other source would not be considered as valid.
9. He will submit leave address before him leaving the country;
10. He will not accept any stipend for his visit abroad during above mentioned period;
11. He will not attend any job interview etc. in abroad without permission.
