OFFICE ORDER

Subject: Regularization of Absence Period of Junior Residents (JRs) and Senior Residents (SRs) during August 04, 2024 to August 22, 2024, in light of Hon'ble Supreme Court Order in Suo Moto Writ Petition (Criminal) 2/2024, I.A. No. 203687/2024 and 223279/2024 in I.A. No. 187964/2024 in matter regarding Alleged Rape And Murder Incident of A Trainee Doctor in R G Kar Medical College and Hospital, Kolkata and related issues.

The Hon'ble Supreme Court of India while hearing the Petition on the subject noted above 22/08/2024 had ordered as follows:-

"An apprehension has been expressed on behalf of the doctors stating that they are being proceeded against for the protests which took place in the past. We are expecting compliance with the assurance which has been given to the Court that the doctors would join normal duties. In the meantime, if any adverse action has been taken against any protesting doctor for protests which have been carried out prior to the date of this order, no coercive steps shall be taken against them."


Further, the Hon'ble Supreme Court of India in its Order dated 29/01/2025 further observed that:-

"In our opinion, the intent behind the order dated 22.08.2024 is that the aforesaid period should be regularized and no penal or coercive steps should be taken. This being the intent, we deem it appropriate to clarify that the period of absence, in case the protesting doctors had joined after passing of the order dated 22.08.2024, would be treated as regularized and not as on leave."

In the light of above clarification by the Apex Court, observation of the DH&FW in the matter that MD-GTBH is competent to take a decision in the matters related to Junior Residents and Senior Residents, the undersigned hereby orders that:-

- (a) The period of absence for Junior Residents (JRs) and Senior Residents (SRs) of GTB Hospital, who participated in the strike from August 04, 2024, to August 22, 2024, is hereby regularized. This period shall not be treated as leave and the period shall be treated as on duty for all purposes.
- (b) The Drawing and Disbursing Officer (DDO), GTBH, is hereby directed to release the salaries of the JRs and SRs who were on strike during the period from August 04, 2024, to August 22, 2024, without any further delay.
- (c) All concerned HODs are directed to take note of this order and implement it accordingly.
- (d) All JRs & SRs of GTB Hospital are also advised to restrain from participating in strike in Hospital adversely affecting patient care.

This issues with the prior approval of MD, GTBH.
