- Qualification:** Passed MDS (not before 11.08.2022 i.e. within 05 years prior to last date of application).
- Leave:** As per CCS Temporary Service (leave) Rules, 1972. No salary will be paid for any kind of unauthorized absence from duty even by the name of Strike.
- DDC Registration:** Regarding registration of DDC, the candidates should be registered with Delhi Dental Council or should have applied for at the time of joining, if selected. Otherwise the candidate will not be allowed to join.
The candidates, holding inter-state or intra-state valid registration with any State Dental Council of the Country is eligible for their candidature being considered for appointment to a post/position by any of the Medical Institutions function under Govt. of NCT of Delhi or elsewhere. However, once the job is offered, they are required to get his registration transferred to the Delhi Dental Council as per provisions of Section 46A of the Dentists Act, 1948 as per letter bearing no. DDC/intere-state/Intra-state registration/2009//1439/dated 22.12.2009 issued by Dr. Mahesh Verma, Registrar (DDC)
- Age Limit:-**Upper age limit for appointment including Statutory/Autonomous bodies wholly financed by Central Govt. has been decided as 45 years as on interview date as per Order No. DHFW/Q015/57/2016-HR-Medical-Secy(H&FW)#1245062/1502-08 dated 26.11.2020 and Age Limit is relaxable by 05 years for SC/ST candidates 03 yrs for OBC candidates.

- (e) **Admissible Emoluments:** Rs.67,700/- as per 7th CPC and other allowances as admissible under rules.
- (f) **Tenure:** Initially for one year and may be extended on yearly basis maximum upto 03 years subject to satisfactory work and conduct report and willingness of the officer and availability of post in concerned department. The officer is required to apply for extension before one month of completion of his/her tenure. However, the total duration of senior residency cannot go beyond three years (Ad-hoc + Regular), in any circumstances, including the duration of senior residency already rendered by him/her in any govt./ public sector undertaking hospital.
- If any post remains vacant due to non applying/non-availability of particular category candidates, the same be filled from suitable candidates of any other category on Ad-hoc & emergent basis for a maximum period of 44 days or till the fresh incumbents join on regular basis, whichever is earlier & their appointment may be terminated earlier on joining of Senior Residents (Dentistry) on regular basis.
- (g) **Residency Scheme:** He/she will work under residency scheme applicable to him/her from time to time.
- (h) **Fee payable: Demand Draft of Rs.500/- in favour of "Medical Superintendent" GTB Hospital,** will have to be annexed with the application as application fee. (Application fee is non-refundable). The Demand Draft should be issued on or after the date of publication of advertisement. "No application fee will be charged from SC/ST/PH/EWS Candidates.

GENERAL INSTRUCTIONS

- (a) Inter Hospital/Inter Institutional transfer shall not be permitted.
- (b) The candidates who are already in Govt. Service should submit NOC.
- (c) The candidates who are working on Ad-hoc basis in GTBH shall have to apply afresh.
- (d) The service will be governed by the Residency Scheme.


